Road repair and improvements

Leon moved to accept American Asphalt Option 1 Bid with Fine Grade and Pave 4" **3"** with 2' Shoulders (3/4" CABC) total quote for 3" of pavement \$98,214.06 Hank seconded, motion passed.

Leon moved to accept JJ's Brush Cutting Service mowing grass, ~~2 passes~~ **1 pass** in early June or July then in the fall 3 to 4 passes total bid \$7605, Hank seconded; motion passed.

Hank moved to accept Wisconsin Salt Solutions Calcium Chloride with Beet juice rust inhibitor at \$1.26 (\$1.14 calcium + .12 additional with beet juice) per gallon total of 4500 gallons, Leon seconded, motion passed. Focus will be spreading near end of driveways.

No spraying of grass will occur 2021, will disc in edges of road and grade reclaimed gravel. Recommend replacing culvert on Smokey Hill Road. Bridge report found acquired bridge on CTY F (between Trestik and Hwy 10) has rotten I-beam. Double 8-foot culvert/bridge on Yellowstone between Brookside and Rangeline is partially clogged requires clearing and maintenance. Connie, Ron, Hank, & Leon will set up time to check out Town of Eau Pleine tractor.

Recycling Center – Filled four dumpsters of recyclable white goods on May 15. Received \$2232.14 recycling grant that was remitted to the Sherry-Milladore Recycling Center.

Emergency Management/Fire Department/EMS – Completed calculation for 2021 Tax Roll Assessment Total is \$29,639.56 divided into two payments for July and December 2021. Six-month payment of Tax Roll assessment to Sherry Fire department of \$14,819.79 will be paid July 2021.
